## Pamlico County Schools Teachers Receive Grants

Three teachers from Pamlico County Schools received grants from the Pamlico County Education Foundation to enhance the educational opportunities in their classrooms and schools.

Elizabeth Harwick, Fred A. Anderson Elementary School, received a \$650 grant from the Pamlico County Education Foundation and teamed it up with her \$400 teacher of the year award to purchase a classroom set of Ozobots. Ozobots are mini robots that blend the physical and digital world by allowing students to use their programming skills to interact with the robot. Ms. Harwick's fourth grade students are currently learning beginning coding and this real world application is the next step to keep the students excited and motivated. Congratulation to Ms. Harwick.

Kim Prescott, Pamlico County Middle School, received a \$300 grant to have a local author, John Claude Bemis, visit the school. The purpose of the visit will give students a chance to meet a large-scale author that was

born and raised in Pamlico County. The goal is to excite students about reading and writing through his presentations and workshops. We are experiencing by far the highest rates of the community using this center since it was built. Based on previous years' usage patterns, I last fall projected that the majority of weekends the center would have no community use. Thankfully, usage will exceed my expectations by more than 500% the first half of this year. In fact, currently there are only six weekends that the Delamar Center has not been reserved between now and the end of July!"

**Does PCC have additional plans to serve the community's non-profits in new ways?**





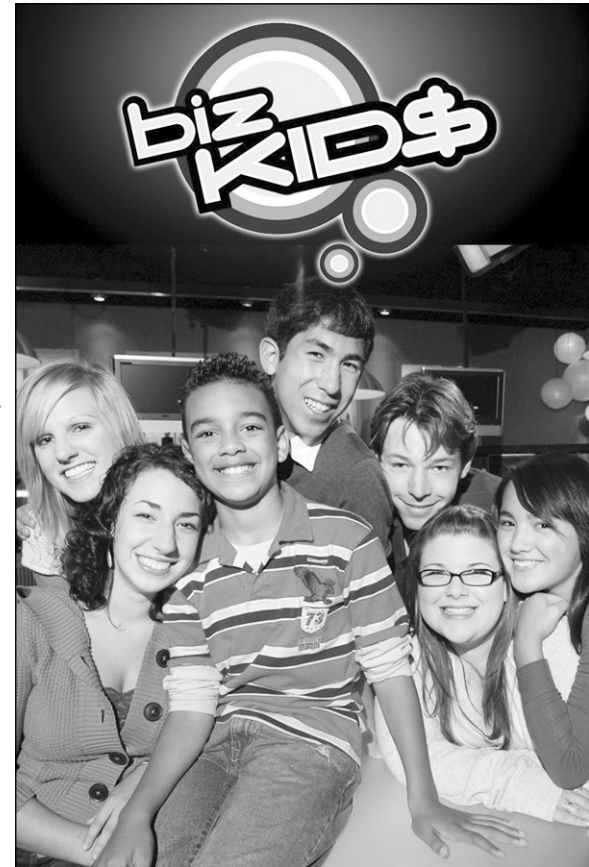


## SECU Members Extend Their Youth Financial Literacy Efforts with Additional Biz Kid\$ Funding

Raleigh – State Employees’ Credit Union (SECU) members are continuing their support of financial literacy for North Carolina’s youth by providing a \$75,000 grant from the SECU Foundation to help fund Season 6 production of the Biz Kid\$ public television series. This grant follows the Foundation’s previous donations to the Emmy award-winning Biz Kid\$ series, as SECU members provided \$125,000 in 2009 and \$250,000 in 2011 for production of Seasons 3, 4 and 5.

Introduced by SECU’s staff to North Carolina schools, Biz Kid\$ programming can be viewed on several University of North Carolina Public Television Network stations and is a fun and educational middle school financial education curriculum that teaches kids about money and business. It keeps them engaged in the learning process of managing money,” said Jim Johnson, SECU Foundation Board Chair. “SECU strives to find creative ways to help youth understand and develop good spending and saving habits – essential life skills needed to help them become financially healthy.”

Last year, SECU reached top spots in the National Youth Involvement Board’s award program, which recognizes credit unions’ youth financial education presentation efforts.

**Financial Focus****On Valentine's Day, Consider Financial Gifts?**

Last year, Americans spent more than \$19 billion on Valentine's Day gifts, according to the National Retail Federation, with the majority of this money going to flowers, candy, cards and an evening out. These gifts were thoughtful, of course, and no doubt appreciated, but they were also somewhat disposable, for want of a better word. On the other hand, some financial gifts can have a pretty long "shelf life."

Beyond simply enclosing some money in a card, what sort of financial gifts can you give? The answer depends somewhat on the recipient. For example, if your sweetheart is also your spouse, some of the gifts suggested below may be redundant to the financial moves you make together. However, if you aren't married, or if you and your spouse maintain separate finances, these ideas may make excellent Valentine's Day presents:

- **IRA contributions** – Technically, you can't contribute directly to someone else's traditional or Roth IRA, but you can write a check to your loved one – although, of course, he or she is free to use the money for any purpose. Like most people, your valentine may not usually contribute the yearly maximum amount – which, in 2017, is \$5,500, or \$6,500 if you're 50 or older – so your check should be quite welcome. A traditional IRA can grow on tax-deferred basis, and contributions may be tax-deductible. (Taxes are due upon withdrawal, and any withdrawals you make before you reach 59½ may be subject to a 10% IRS penalty. A Roth IRA's earnings are distributed tax-free, provided with-

drawals aren't taken until the account owner is 59½ and has had the IRA for at least five years.

- **Charitable gifts** – Consider making a gift to a charitable organization supported by your loved one. When you send cash to a qualified charity, you can get a tax deduction, but you might gain even bigger benefits by donating appreciated securities you've held for more than one year. By doing so, you can generally deduct the value of the securities, based on their worth when you make the gift. Plus, neither you nor the charity will have to pay capital gains taxes on the donated investments.

- **Contributions to an emergency fund** – It's a good idea for everyone to maintain an emergency fund to cover unanticipated expenses, such as a major car repair, a furnace or out-of-pocket medical bills. If your valentine doesn't have such a fund, consider helping him or her establish one, with the money going to a liquid, low-risk account.

- **Gym membership** – Although not actually a "financial" gift, a gym membership can nonetheless bring some positive economic results to your valentine. For one thing, the insurance industry is providing more incentives to encourage people to exercise and live healthier lifestyles. But even if a gym membership doesn't give your loved one a break on insurance premiums, it can nonetheless result in better physical conditioning, which, in turn, could ultimately result in lower medical costs.

On Valentine's Day, you may still want to get your sweetheart something associated with the holiday. But if it's within your means to do so, also consider one of the above suggestions for financial gifts. Your generosity will still be felt long after the chocolates are eaten and the flowers have faded.

**Devolve Transportation to the States**

RALEIGH — With all the furor and protests accompanying the launch of the Donald Trump administration, you might assume there's little room for bipartisan cooperation in Washington.

That assumption is mistaken. The new president says he'd like to enact a 10-year, half-trillion-dollar program of infrastructure investment. Congressional Democrats and traditionally Democratic interest groups such as trade unions love this idea. Many Congressional Republicans and traditionally Republican interest groups love the idea, too. So do some North Carolina politicians who

hope the package will pay for long-needed improvements to our stretch of I-95.

I don't love the idea. I worry that whatever emerges from Capitol Hill will be covered in regulatory strings and stuffed with pork-barrel projects. More fundamentally, I want to see the federal government's role in infrastructure reduced, not strengthened. This is an old story in American politics. Throughout the 19<sup>th</sup> and early 20<sup>th</sup> centuries, special-interest groups that couldn't get their favorite projects funded at the state and local levels went to Washington. At first, they were often rebuffed by federal lawmakers and presidents who recognized that "internal improvements" were mainly a state and local responsibility under our constitution, not a federal one.

Eventually, the spending lobbies wore down the opposition. One of the arguments they made was a constitutional one, that the federal government had a responsibility to finance infrastructure if it was necessary for national defense. The initial trunks of the interstate-highway system fit that parameter, because of the need to move troops and weapons rapidly and efficiently.

But as the system proliferated and commercial uses completely overwhelmed the potential military ones, its planning and financing should have reverted to the states. Other infrastructure projects such as airports, seaports, and railroads should never have had significant federal involvement in the first place.

One reason is that those transportation options could always be financed by charging users directly. Automotive transportation

couldn't, because of the difficulty of excluding nonpayers from the roads. Automotive transportation remained mostly a private enterprise, mind you — household and business expenditures to purchase, operate, maintain, insure, and fuel cars and trucks represent about 80 percent of the system's cost. But the remaining portion, the underlying roads, were financed by a combination of direct user charges (tolls and fees) and indirect user charges (gas taxes levied by the gallon).

State politicians wanted to get roads built without facing the potential political consequences of raising user charges or taxes. Securing "federal money" from Washington was a welcome expedient, although of course all the money originated in the states, flowed through the nation's capital, and then came back (minus shipping and handling charges).

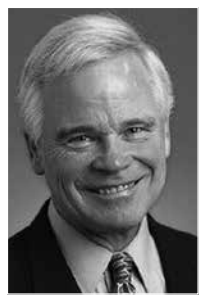
What should we do now? The worst idea was former President Barack Obama's plan to "reform" the corporate income tax — increase its burden, that is — and then use the proceeds to finance new projects. Infrastructure does confer net economic benefits, on average, but they aren't large enough to offset the economic damage inflicted by higher corporate or personal income taxes, as a new Tax Foundation study illustrates.

Raising gas taxes or other user fees is a better idea, although still unpopular and prone to be a net waste of money in many instances. In any event, Washington shouldn't do it. If more revenue is truly needed, states and localities should raise it. That will make it less likely the money will be spent on low-priority projects.

The best idea of all, however, is to pay for new road investment by reducing government expenditures on other things. For the most part, that's what North Carolina has been doing over the past decade, by ending about \$400 million a year in transfers into the General Fund out of the Highway Fund and Highway Trust Fund. These gas and car taxes would have been spent on something else, but are now being spent on road construction and maintenance. Good.

If the Trump administration and Congress really want to improve infrastructure policy in America, they'll devolve it to the states as much and as soon as possible.

**D.G. Martin Column—One on One****The Wilmington Ten and the Women's March on Washington**

"The case of the Wilmington Ten amounts to one of the most egregious instances of injustice and political repression from the post-World War II black freedom struggle. It took legions of people working over the course of the 1970s to right the wrong."

These opening words from Kenneth Janken's book, "The Wilmington Ten: Violence, Injustice, and the Rise of Black Politics in the 1970s," alert readers to the importance of the story he tells and to the passionate viewpoint from which he writes.

In today's times of Black Lives Matter and the Women's March on Washington, why is the Wilmington Ten story important for us?

One reason according to the Wilmington StarNews journalist Ben Steelman is "the Wilmington Ten case still divides Wilmington like an ugly scar."

That story begins in 1971 when the treatment of black students in Wilmington's newly integrated high schools prompted a boycott and demonstrations, followed by violent confrontations and the burning of small businesses. It ended only on December 31, 2012 when Governor Beverly Perdue issued a pardon of innocence for 10 people who had been charged and convicted of arson and related crimes in connection with the 1971 burnings.

Janken sets out the tortured story that took place between those two dates.

\*Since no other nearby black church was willing to host the boycotters' potentially inflammatory demonstrations, they established their headquarters at a mixed race United Church of Christ church led by white pastor, Eugene Templeton.

\*When boycott and protest efforts were faltering, Templeton asked his denomination to send someone to provide leadership training for the protesting students. The person they sent was the charismatic Ben Chavis, who had been active in demonstrations in Oxford and in other eastern North Carolina towns.

\*After Chavis arrived, confrontations among demonstrators, white power groups, and law enforcement officials accelerated. On the night of February 6-7, 1971, Mike's Grocery was

destroyed by fire.

\*A year later in March, 1972, Chavis and others associated with the boycotts and demonstrations were arrested and charged with arson.

\*Using perjured testimony that he helped develop, the prosecutor secured a conviction of the 10 defendants known as the Wilmington Ten. The group was sentenced to a cumulative total of 282 years.

\*Janken asserts that the prosecution had broad support from political and community leaders who wanted to prevent Chavis from stirring up more demonstrations in Wilmington and other parts of the state.

\*Early appeals of the conviction and sentencing on the grounds of prosecutorial and judicial misconduct were unsuccessful.

\*Many in North Carolina believed that Chavis and others in the group were guilty of something, even if they did not put a match to Mike's Grocery. But people in other parts of the country and in many other lands took up the cause of the Wilmington Ten. These groups pummeled North Carolina with petitions and demonstrations. They cast a negative shadow on our state, something similar to the one cast today by House Bill 2. These activities also mobilized and provided an organizational vehicle for supporters of other progressive causes just as the Women's March on Washington did this year on January 21.

\*In January 1979, Gov. Jim Hunt shortened the sentences of the Wilmington Ten, leaving some of them still in prison.

\*In 1980 a federal appeals court threw out all convictions.

Janken believes the memories of the 1898 Wilmington violent political revolution that ousted black officials had an impact on the activities of 1971, and particularly the unwillingness of some leading members of the black community to support the student boycott. Similarly, the Wilmington Ten story is for many, a flash-point of history that will burn for many years to come.

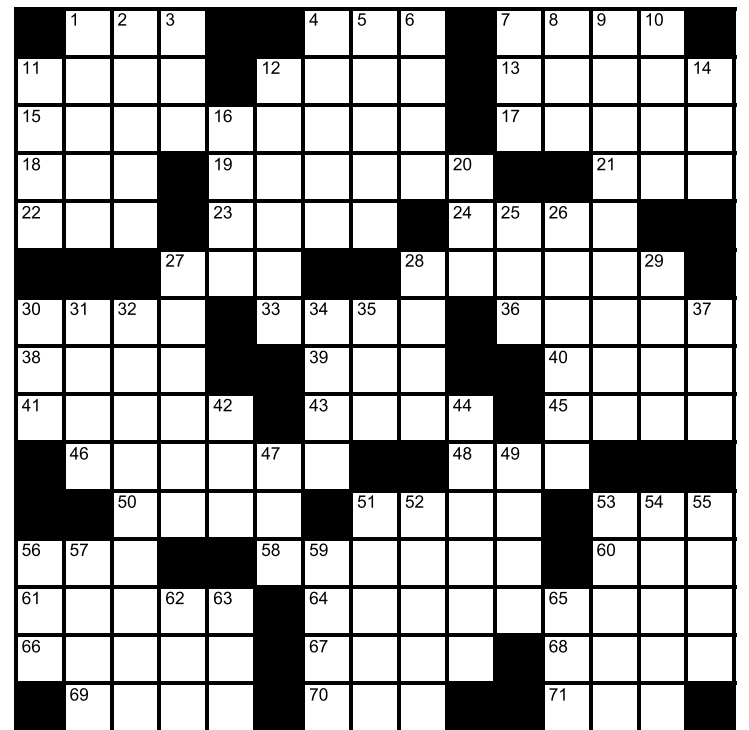

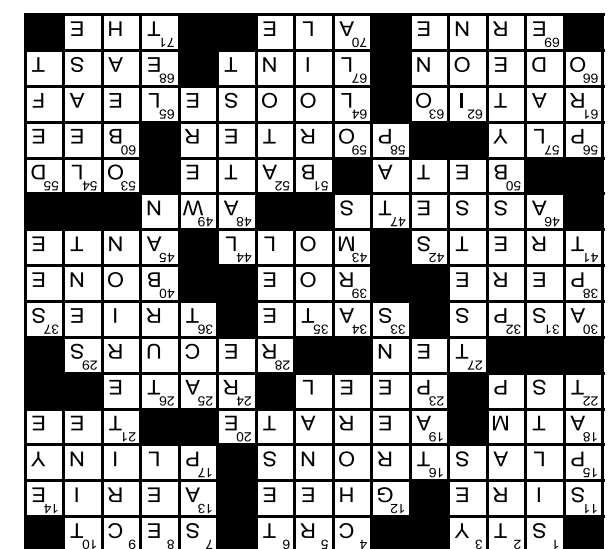

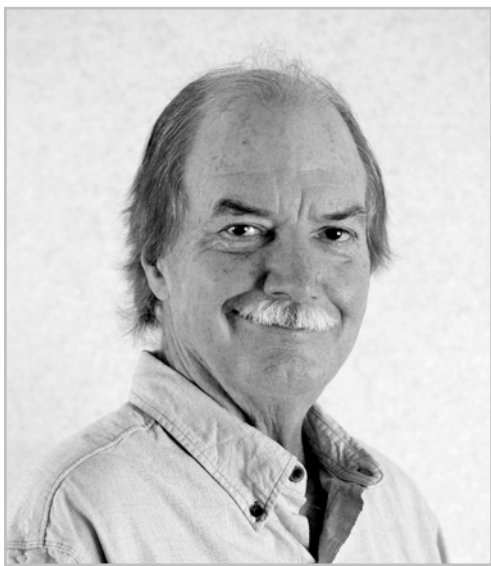

# Boatbuilder Shares His Craft With Students

Heber Guthrie, a member of the Speakers Bureau for The NC Coastal Heritage Association, a 501-C3 nonprofit dedicated to documenting and preserving the cultural heritage of coastal communities, recently entertained fifth graders from Atlantic Elementary School at Little Skiff Boat Boatworks in Marshallberg.

One part of the class assembled parts of a Core Sound workboat as others shaped and formed a traditional oar used on Core Sound skiffs. Guthrie, a veteran boatbuilder from Gloucester, had pre-cut the boat parts for the students to assemble while receiving hands on instruction during the two hour session. He will be conducting a series of summer camps for both young and old to learn boat building skills presented within a framework of lessons on coastal heritage.

Considering the skills required to thrive working on the water, men had to become skilled at making and mending nets as well as building a boat to haul nets and bring home the catch. And in the off-season winter months, the demand for duck decoys for hunters from near and "from off" created a new industry that flourished on the coast.

Ben and Carolyn Casey, while conducting interviews and research for their book, *Sound People*, have encountered a well-known phenomenon throughout Down East Carteret County. Acquiring and using these skills has shaped a way of life, a cultural heritage, not just Down East, but in communities from Corolla to Calabash. Innovations, technology, a downturn in commercial fishing, and encroaching development are dissolving the cultural heritage in so many small coastal towns. Just as Rachel Carson observed that lines between land and sea constantly dissolve and form new boundaries between sea and shore, so do cultural boundaries along the coast.

Ben Casey commented, "A while back, Confucius noted that one needed to study the past in order to define the future. More recently, Stevie Wonder said that to be ready for the future, you had to remember the past. I submit that the cultural values of the past are perhaps more valuable than the technological advantages that are permeating the present and shaping the future of small coastal towns."

Civic organizations and schools are encouraged to visit the NCCCHA website, [nccoastalheritage.org](http://nccoastalheritage.org) to learn more about possibilities for speakers and programs of interest to residents all along the NC coast. The Speakers Bureau is in its developmental stages with many available programs not yet listed on the website. Groups can request a program about specific topics related to the coastal heritage in specific locales and the NCCCHA will identify a knowledgeable person to make the requested presentation.

The public, from the sea to the mountains, is invited to visit the Association's website, join, and donate to the various projects underway.

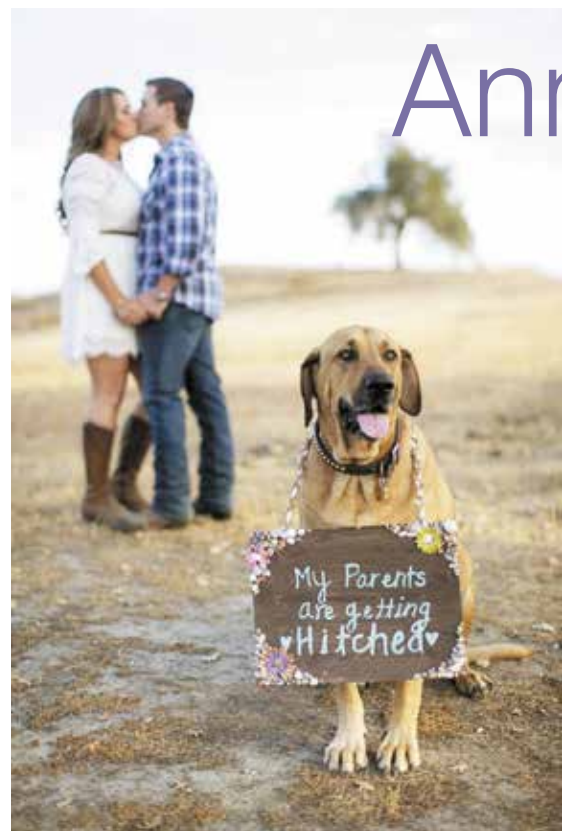
## Oriental Drug Investigation Leads To Arrest

## AG Stein Announces Settlement to Crack Down on Fraud: NC joins 48 States and D.C. in Settlement with Western Union

RALEIGH – Attorney General Josh Stein today announced that Western Union will take new steps to protect their customers from fraud and that North Carolina will receive \$226,000 of a \$5 million settlement with Western Union. North Carolina joined 48 states and the District of Columbia to reach this settlement, which is the culmination of an investigation into schemes to defraud people who used Western Union's wire transfer service to send money to third parties. "Keeping North Carolinians safe – including from scam artists out to commit fraud – is my number one priority as Attorney General," said AG Stein. "There are too many creative and believable scams that trick people every day. I'm proud to join my colleagues across the nation to require Western Union to implement anti-fraud programs to better protect people."

Consumers should be aware of some of the scams that led to this settlement: lottery scams occur when a consumer receives a notice that he or she has won a large sum of money, but must first pay taxes or other fees to get it; contest winnings should never require money up front and Grandparent scams happen when a criminal calls someone pretending to be his or her grandchild and says he or she urgently needs money. These scammers get family names from social media, obituaries in the newspaper and other sources, so they may have a lot of information about the people they're calling and impersonating. The best thing to do when this occurs is hang up the phone and call the grandchild or loved one directly to confirm. Sweetheart scams are those when someone begins an online romantic relationship in which the person being scammed is tricked into paying money for medical emergencies, car accidents, emergency travel, etc. If you meet someone online, always be very cautious about wiring money.

In addition to paying \$5 million for the states'

costs and fees, the agreement requires Western Union to develop and put into action a comprehensive anti-fraud program to help detect and prevent incidents where people who have been the victims of fraud use Western Union to wire money to scam artists. The program includes: anti-fraud warnings on send forms that people use to wire money; mandatory and appropriate training and education for all Western Union agents about fraud; heightened anti-fraud procedures when needed, such as when fraud complaints increase; due diligence checks on Western Union agents who process money transfers; monitoring of Western Union agent activities related to fraud prevention and prompt and appropriate disciplinary action against Western Union agents who do not follow required protocols concerning anti-fraud measures.

Western Union also settled claims with the Federal Trade Commission and the U.S. Department of Justice this month. As part of those settlements, Western Union will pay \$586 million to a fund that the U.S. Department of Justice will administer to provide refunds to fraud victims, including those in North Carolina.

## Bayboro Man Leads Authorities On Vehicle Chase

A Bayboro man was arrested in Beaufort County after leading deputies on a vehicle chase. On Thursday, 29 year old Jermaine Gibbs was arrested and charged with possession with intent to sell, deliver, and manufacture heroin, flee to elude arrest, reckless driving, driving while license revoked, and possession of drug paraphernalia.

The incident began when authorities received a call reporting a possible overdose on Big Hill Road in Edward. Gibbs was suspected of selling

heroin to that person. Deputies spotted Gibbs driving a light gold colored Nissan Altima on Tunstall Swamp Road and attempted to conduct a traffic stop. He refused to stop and led authorities on a vehicle chase for ten miles while throwing heroin and plastic bags out the window.

After being apprehended, investigators say they recovered digital scales and packaging materials inside the vehicle in addition to the drugs that had been thrown during the chase. The overdose victim was transported to the Beaufort County Hospital by EMS and reported to be in stable condition.

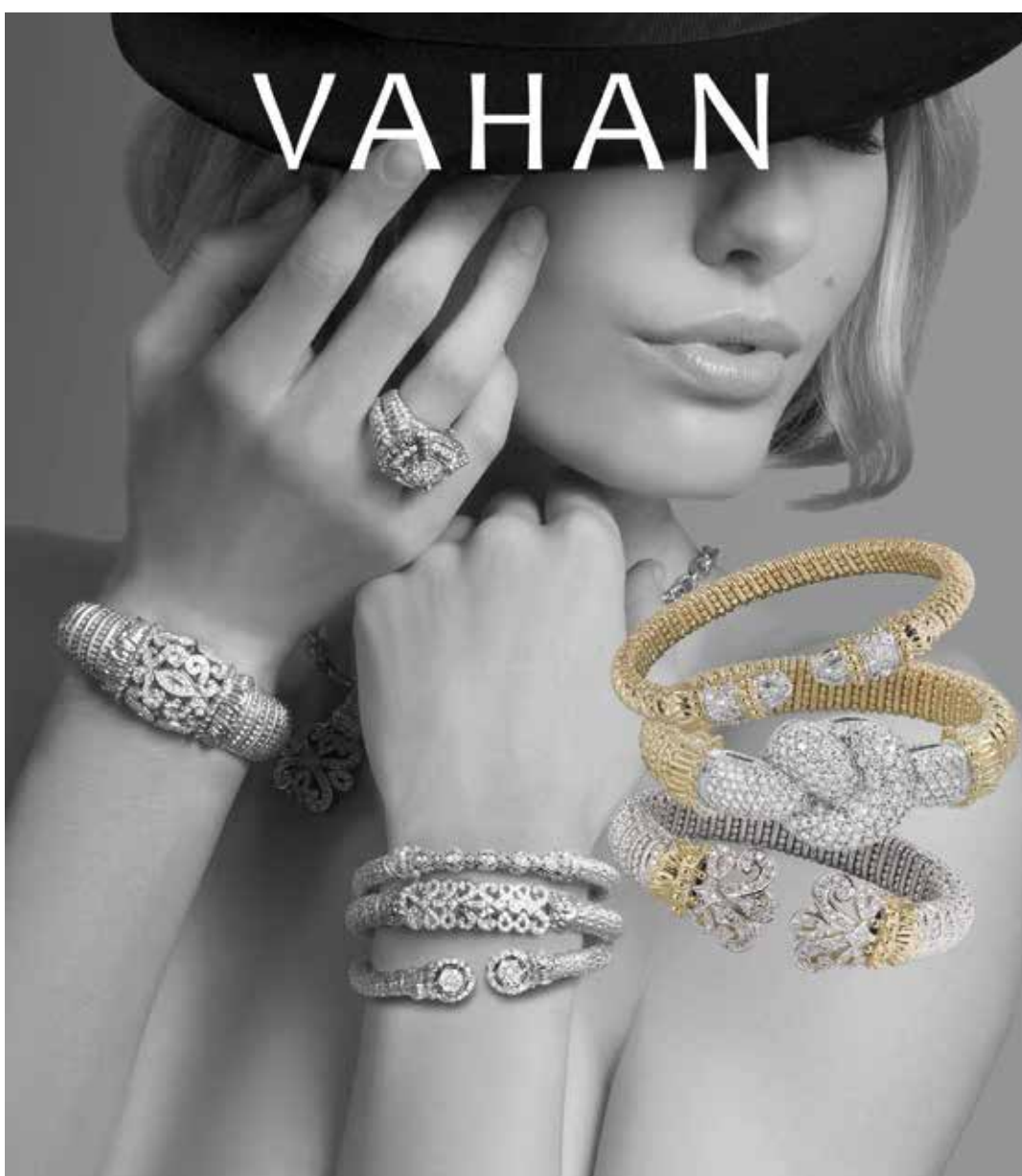
