School Board Votes to **Implement Move** to Plan A

In a special called Pamlico School Board meeting on October 28th, Board members were presented a plan to transition grades K through 5 into Plan A of face to face instruction. This plan was offered at the special meeting so that board members could have time to think about the proposal and listen to any concerns their constituents may have before the regularly scheduled November board meeting on Monday night.

The plan, presented by superintendent Lisa Jackson, calls for all K-5 students to transition to a face to face learning environment of four days a week instead of the two days a week currently in plan B. This would be done in a staggered implementation beginning on November 5th with the Kindergarten and first grade students. Second and third grades would follow the next week on November 12th and fourth and fifth graders the following week on November 19th. All students would attend classes on Monday, Tuesday, Thursday, and Friday with Wednesday remaining as an at home learning day to allow for deep cleaning at the schools and for teacher planning. No other changes will be implemented except since classes will now be of normal size, students will be required to wear

EPA rolls back regulatory standards at Aurora phosphate company

AURORA, N.C. (WITN) - The head of the Environmental Protection Agency was in Eastern Carolina on Thursday to announce a rollback on regulations for Nutrien Aurora Phosphate.

EPA Administrator Andrew Wheeler announced the relaxing of a standard for phosphoric acid manufacturing he says is not expected to result in an increase in mercury or any other hazardous air pollutant.

The EPA says the move will save \$26 million over the next five years and keep hundreds of jobs in place. In 2015, the EPA under the Obama administration announced new rules for phosphoric acid manufacturing under the National Emission Standards for Hazardous Air Pollutants.

The company, then PCS Phosphate, petitioned the EPA in 2016 under the Trump administration to adjust its standards with respect to phosphoric acid manu-

The EPA in a news release says it made the revision, "based on newly available data and after conducting a site visit, that the previous standard was not based on an accurate determination of the level of emission reductions that were achievable at the source."

The closest military installation to Pamlico County is Marine Corps Air Station Cherry Point which is located just across the Neuse River at Havelock, North Carolina. The U.S. Congress authorized construction of the air station on July 9th, 1941 and clearing and construction began later that year on what was then known as Cunningham field. It was renamed Marine Corps Air Station Cherry Point after the nearest post office, at that time, to the new base. Its primary purpose was to train Marines and pilots for service in the Pacific during World War II, but it also served as a base

for anti-submarine patrols off our coast. These patrols reaped dividends on July 7th, 1942, when an Army A-29 Hudson bomber flying from the new base sank the German U-boat U-701 about 10 miles east of the Diamond Shoals light tower.

Pamlico Community College's Continuing Education division plans busy November

Pamlico Community College's Continuing Education division is starting the new month strong with a mix of familiar courses and new offerings to help men and women develop new skills for the workplace.

The courses will feature face-to-face instruction, while one of them will be offered in a hybrid (part-seated, part-online) format.

"Our Continuing Education division does a great job tailoring its course offerings to the needs of local employers and employees," said PCC President Dr. Jim Ross. "The college is always looking for new opportunities to bring skills-based training to PCC so we can prepare men and women for new jobs or to help them become more valuable at their current jobs."

In that spirit, PCC will be offering an Introduction to Computer-Aided Design and 3-D Printing course on Thursdays beginning Nov. 12. The class, which will be taught by Welding Instructor Joe Flynn, will include face-to-face instruction as well as some web-based training.

PCC will offer the next edition of its popular Nurse Aide II course beginning Tuesday, Nov. 17. The class will meet on campus Tuesdays and Thursdays from 5 to 9 p.m.

The college's next one-day Forklift Training course is set for Saturday, Nov. 21, on campus. Also that day, PCC will offer its one-day Notary course in Bayboro.

Looking ahead, December will feature two opportunities for food service workers to participate in ServSafe training. There will be a one-day course on Monday, Dec. 7, and a full training course Dec. 14 to 17.

Finally, the college is forming new Basic Skills classes for men and women who need to earn their high school equivalency or who need to learn to speak English. All Basic Skills courses are offered free of charge.

"We work hard to schedule courses and programs that will meet the training needs of our community," said Lori Giles,

but we've gone over it and can manage the changes." There are no changes to grades 6 through 12 who will remain in Plan B.

On one point, everyone from board members to administration to staff, was in complete agreement. A motion was made to accept the proposal to move forward into plan A and the motion passed unanimously. As Chairman Prescott said, "we are navigating uncharted waters."





What is on your fall and winter preparation list for your horse? Stockpiling hay? Establishing winter forages in your pastures? Getting blankets ready? What about deworming? Just because the temperature starts dropping, does not mean the parasites will drop off as well.

With any deworming treatment, a fecal count needs to be done first to determine parasite load and type of parasite. A fecal count is an estimate of the number of parasite eggs in a horse. Once we know the count and the type of parasite, we

can treat it with the most effective dewormer to ensure the parasite load is being reduced. The important deworming season in North Carolina is September - April. During the summer months of May - August, parasite egg numbers in pastures are much lower and deworming is less of a priority due to the hot summer temperatures.

Horses shed parasitic eggs differently, for example, yearlings tend to shed small strongyles at higher amounts than adult horses. It is important to know the rate at which your horse sheds. A low shedder fecal count will be <200 EPG (eggs per gram of manure). Moderate shedder fecal counts will be 200-500 EPG, and high shedder fecal counts will be >500 EPG.

Before starting any deworming regiment, you should consult with your vet. They will recommend the best treatment course that will minimize parasite loads and avoid building a resistance to deworm-

Low shedders (<200 EPG) can be dewormed twice a year, in the spring and fall seasons. In the spring Ivermectin (Equell®, Zimectrin®, Rotectin®, IverCare®), and Moxidectin (Quest®) can be used. In the fall Ivermectin w/Praziguantel (Equimax*, Zimectrin Gold®) or Moxidectin with Praziquantel (Quest Plus®) are dewormers that can be administered.

Moderate shedders (200-500 EPG) may need to be dewormed frequently throughout the year. A spring deworming can be done using Ivermectin (Equell®, Zimectrin®, Rotectin®, IverCare, etc), Moxidectin (Quest®) or double-dose Fenbendazole for 5 days (Panacur® PowerPak). In late summer, Pyrantel Pamoate (Strongid paste®, TapeCare Plus®, etc), or Fenbendazole (Panacur®, Safe-Guard*) can be given. In early winter, Ivermectin w/ Praziquantel (Equimax®, Zimectrin Gold®) or Moxidectin with Praziquantel (Quest Plus®) can be administered.

High shedders (>500 EPG) may need to be dewormed with every season change. In spring again Ivermectin (Equell*, Zimectrin*, Rotectin®, IverCare®), Moxidectin (Quest®) or double-dose of fenbendazole for 5 days (Panacur* PowerPak) can be given. During the summer Pyrantel Pamoate (Strongid paste*, TapeCare Plus*), Fenbendazole (Panacur, SafeGuard®) or Oxibendazole (Anthelcide®) can be used. In fall Ivermectin w/ Praziquantel (Equimax*, Zimectrin Gold®) or Moxidectin with Praziquantel (Quest Plus®) will be effective. And during the winter season Pyrantel Pamoate (Strongid paste®, TapeCare Plus®), Fenbendazole (Panacur®, SafeGuard®) or Oxibendazole (Anthelcide®) can be administered. When it comes to pregnant mares and foals that are two months old, consulting with your vet is important for proper care so they can help determine the best treatment plan.

There are other ways to lower parasite loads in horses in combination with deworming. One being rotational grazing. Rotating pastures is not only good for forage regrowth, but parasite eggs that are shed in the manure are not ingested as quickly by a host and die out. Cross grazing pastures with ruminants such as cows, goats, and sheep is also effective. Parasites that are common in equine are not found in ruminants and vice-versa. In the summer months spreading or dragging manure is beneficial both for parasite reduction and spreading of nutrients found in manure over the pasture. This also keeps the nutrients buildup down in high manure concentrated areas. In winter months the removal of manure is also helpful in decreasing parasite numbers. Doing these things with a parasite control program approved by your vet can keep your horse healthy

DENC filed an application and testimony relative to the subject matter of this proceeding on August 11, 2020. According to its application, DENC is requesting a total annual fuel revenue decrease of approximately \$15.7 million from the fuel and fuel-related costs currently in effect. Further, DENC proposes to make the fuel revenue decrease effective for service on and after February 1, 2021.

DENC's proposed fuel revenue decrease, including regulatory fee, would result in the following decreases for DENC's customers: 0.389 cents per kilowatt-hour (kWh) for residential, outdoor lighting and traffic lighting customers; 0.387 cents per kWh for small general service and public authority customers; 0.384 cents per kWh for large general service customers; 0.372 cents per kWh for rate schedule NS customers; and 0.378 cents per kWh for rate schedule 6VP customers. The net effect of this request would decrease the monthly bill of a residential customer using 1,000 kWh of electricity
